## SOLAR ENERGY

Thanks to the solar energy panels, which have been regularly maintained since the establishment of the hotel, 10% less LNG consumption is provided for water heating.



## WATER

While the water consumption per person was 1.01 m<sup>3</sup> in 2021, the water consumption per person was reduced to 0.55 m<sup>3</sup> with the newly constructed irrigation systems in 2022.



## WATERING SYSTEMS

Water consumption decreased from 94.087 m<sup>3</sup> in 2021 to 79.187 m<sup>3</sup> in 2022 with the addition of automatic timed valves and the transition to the drip and sprinkler method in the irrigation system.



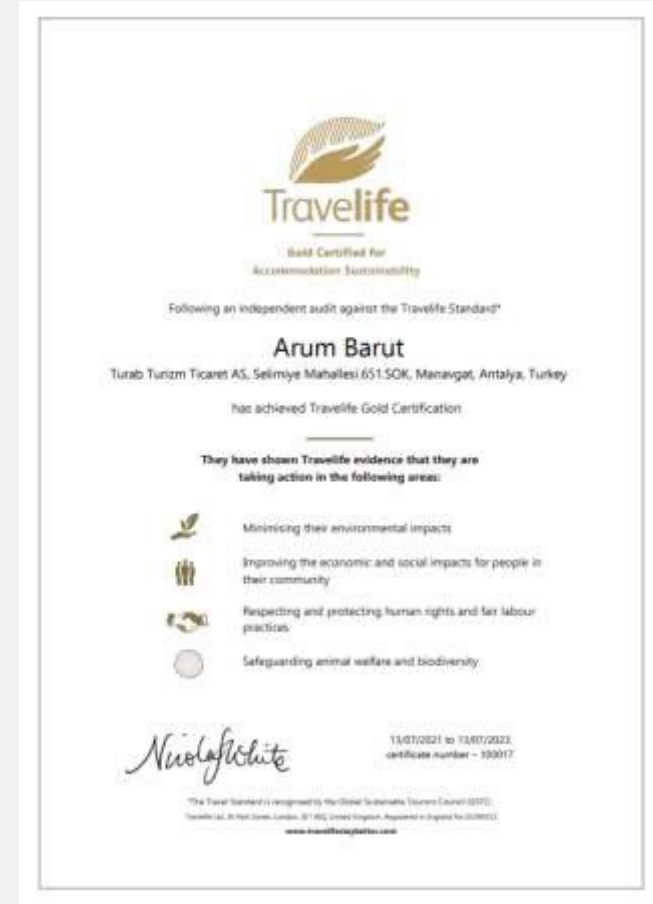
## FUEL
